Description

250mg Chlorella Vulgaris and 250mg Spirulina Platensis pressed to a 500mg tablet. Our organic chlorella and spirulina tablets are a combination of organic chlorella powder mixed with organic spirulina powder and compressed into a tablet form. Both algae are cultivated in fresh water on an island off the south of China. Chlorella, is well known for its use in detoxification programmes. Key vitamins such as calcium, iron and potassium are present within the product. Spirulina, much like the chlorella, is a wealthy source of vitamins, proteins and amino acids. During production, the algae are pressed into tablet form by a registered pharmaceutical grade manufacturer. This product is inspected and meets the standards set by the Medicine and Healthcare Products Regulatory Agency. No bulking agents such as magnesium stearate are used.
