Hemp flour organic

Description

The initially purified, dried, and pasteurized organic hemp seeds are cold pressed. Because this concerns cold pressing, the outflow temperature is max 40C. After oil is extracted, cold press-cake is mechanically grinded and sieved (500 um of grind) for finest particles. No thermal or chemical treatment involved.
